



BILINGUAL SHELTER ADVOCATE

Safe Shelter of St Vrain Valley is seeking a three-quarter time (32 hours) Bilingual Residential Shelter Advocate. We are seeking an individual who is passionate about the prevention of interpersonal and family violence, victim advocacy, and has a strong desire to work with victims of relationship abuse and positively impact the lives of others.

This individual is responsible for provision of crisis intervention, client support, domestic violence education, and development of an action plan for monolingual Spanish speaking adults and children, as well as English speaking adults and children in the Emergency Shelter facility.

We provide opportunities for ongoing professional development and training and offer the opportunity to improve our community and the lives of individuals affected by domestic violence.

Key responsibilities include, but are not limited to:

Residential Client Advocacy

- Provide screening, intake, crisis intervention, safety and needs assessment, ongoing individual counseling, advocacy, and referral services for Spanish speaking adults and their children, as well as other adult and child residents
- Assist clients in development of an Action Plan, maintain progress notes, and provide client advocacy with a wide variety of community agencies
- On a daily basis, assist all clients in adjusting to Shelter living and support clients in reaching personal goals
- Answer phones, take crisis calls, provide advocacy, information, and referrals to callers; provide Spanish/English translation on the phone and in person
- Share, with other Spanish speaking advocates, the Spanish back-up phone line—responding to calls 24/7 while on shift
- Assist clients in exiting Shelter—both voluntary and involuntary exits; refer them to Safe Shelter Outreach and other community services as appropriate

General Duties

- Act as part of the overall Shelter team in providing strengths-based, client determined, trauma-informed advocacy
- Help create and maintain a safe and secure environment for all clients
- Continually identify promising practices in service access and delivery
- Maintain and update knowledge of community resources
- Establish collaborative relationships with appropriate community agencies to efficiently and effectively serve clients
- Provide public speaking and education to the community at large, as needed
- Assist in the training of new staff, volunteers, and interns, as requested
- Assist in creating and achieving program goals and objectives

- Submit statistical data in an accurate and timely manner
- Attend and participate at all Safe Shelter meetings pertinent to duties assigned to the position
- Participate in fundraising and special events preparation, implementation, and attendance throughout the year
- Attend training as pertinent to job duties and professional development
- Assist in minor Shelter maintenance and repair; Prepare rooms for in-coming clients when necessary
- Other duties as assigned

General Qualifications:

- Speak, comprehend, read, and write Spanish and English fluently
- Demonstrate knowledge and understanding of the physical, psychological, and sociological issues involved in domestic violence
- Have a thorough understanding of Latino culture and the dynamics of domestic violence within that community
- Demonstrate experience in crisis intervention, individual, and group counseling
- Communicate effectively –possess excellent written and verbal skills
- Possess a general knowledge of community resources
- Use discretion, think independently, and make decisions appropriately
- Work independently and as part of a team
- Possess and exercise non-judgmental attitudes and compassion in addressing victim issues
- Demonstrate computer skills – primarily Windows and Microsoft programs
- Possess a valid driver's license and proof of insurance

Educational Qualifications:

Bachelor's degree in a social service or related field plus a minimum of two year's work experience in human service delivery programs, or any equivalent combination of education and experience.

Position Status: Salaried, Non-Exempt, three-quarter time (32 hours), Sunday-Thursday. Salary is \$28,000.
